

AIR FITNESS LTD TERMS AND CONDITIONS

THESE TERMS APPLY TO ALL OF OUR PAY-AS-YOU-GO MEMBERS.

1. MEMBERSHIP

YOUR MEMBERSHIP WILL START ONCE YOU HAVE PAID FOR YOUR CLASS CREDITS AND WILL CONTINUE UNTIL ALL CREDITS HAVE BEEN USED OR 12 MONTHS AFTER DATE OF PURCHASE (WHICHEVER IS SOONER). PLEASE BE AWARE THAN ANY CLASS CREDITS REMAINING 12 MONTHS FOLLOWING DATE OF PURCHASE WILL AUTOMATICALLY EXPIRE AND CANNOT BE USED AT A LATER DATE.

ONCE PURCHASED THE CLASS CREDITS CANNOT BE TRANSFERRED OR REFUNDED.

2. AIR FITNESS VENUES AND CLASSES

WE CURRENTLY PERMIT MEMBERS TO ATTEND ANY CLASSES AT ANY OF OUR LOCATIONS. MEMBERS MUST REPORT TO THE TRAINER TO CONFIRM THEIR ATTENDANCE UPON ARRIVAL.

3. CLASS TIMETABLES

AIR FITNESS CHANGES THE SHEDULE OF CLASSES BASED ON VARIOUS CRITERIA INCLUDING BUT NOT LIMITED TO WEATHER, INSTRUCTOR AVAILABILITY OR DEMAND.

AIR FITNESS MAY CANCEL OR MOVE CLASSES AT OUR OWN DISCRETION. IF CLASS WAS CANCELLED OR MOVED REGISTERED PARTICIPANTS WILL NOT BE CHARGED FOR THE SESSION AND THEIR CLASS CREDITS WILL BE RETAINED.

4. ABOUT YOUR MEMBERSHIP FEES

A. CLASS CREDITS

YOU MAY PURCHASE CLASS ON THE WEBSITE, UPON PURCHASING A PACKAGE YOU WILL BE PROVIDED WITH UNIQUE BOOKING CODE. PAYMENT MUST BE MADE IN ADVANCE BY CREDIT, DEBIT CARD OR PAYPALL. WE DO NOT SELL CLASS CREDITS AT OUR VENUES.

5. HOW TO TRANSFER YOUR MEMBERSHIP

YOUR CLASS CREDITS ARE PERSONAL TO YOU AND CANNOT BE ASSIGNED OR TRANSFERRED TO ANOTHER INDIVIDUAL.

6. OUR RIGHT TO CANCEL YOUR MEMBERSHIP

WE WILL CANCEL YOUR MEMBERSHIP IMMEDIATELY IF YOU:

- BREAK THESE TERMS AND CONDITIONS
- PUT THE HEALTH, SAFETY OR WELLBEING OF OTHER MEMBERS OR OUR EMPLOYEES AT RISK
- ALLOW OTHER PEOPLE TO USE YOUR MEMBERSHIP TO ATTEND CLASSES
- ENGAGE IN DISRUPTIVE OR VIOLENT BEHAVIOUR

IF WE CANCEL YOUR MEMBERSHIP, WE WILL REFUND ANY OUTSTANDING CLASS CREDITS.

7. OUR RESPONSIBILITY TO YOU

WE ARE NOT LEGALLY RESPONSIBLE FOR ANY POSSESSIONS YOU LOSE OR THAT ARE DAMAGED OR STOLEN AT THE TRAINING SITE UNLESS WE HAVE BEEN NEGLIGENT. IF YOU HAVE AN ACCIDENT OR INJURE YOURSELF AT ONE OF OUR CLASSES YOU MUST REPORT THIS TO THE INSTRUCTOR STRAIGHT AWAY.
